Question Side	<b>Question Coodinator</b> reviews question and submits to Answer Side	Submitted Question	Separate Question Coordinator and Author roles are only needed when Question Group wants to review questions before submitting. Otherwise all users can submit.
Answer Side	Option 1: Answer Coodinator reviews question and assigns to Expert	Assigned Question	Answer Coordinator manages the Q&A session, routing questions and acts as final reviewer of answers.
Answer Side	Option 2: Expert answers question or assigns	Draft Answer	Questions can be assigned to multiple experts.
Answer Side	Option 3: Answer Coodinator reviews answer and submits for approval	Proposed Answer	Answer Coordinator reviews answers from one or more experts and submits for approval (they can answer directly on their own of course).
Answer Side	Approver reviews the answer and approves	Approved Answer	Alternatively the Approver can reject the answer which will send the answer back to the Answer Coordinator for correction or assignment.




